

NEVADA WOMEN'S FUND Workforce Ready SCHOLARSHIP PROGRAM

Establishing A Workforce Ready Scholarship

Nevada Women's Fund offers a range of donor opportunities, and the establishment of a Workforce Ready Scholarship is a meaningful way to make a lasting impact. This option requires an annual commitment and allows the donor to specify the scholarship's use and purpose.

Key details for establishing a Workforce Ready annual scholarship include:

- Minimum Amount: The minimum donation required to establish an annual Workforce Ready scholarship is \$2,500.
- Donation Deadline: We request that donations be made prior to January 31 of the award year.
- Fund Management: The Board of Directors of Nevada Women's Fund, or its designee(s), retains full authority over the management, investment, and administration of the restricted scholarship gift in accordance with the Fund's management policies.
- Scholarship Allocation: The scholarship fund will be allocated quarterly to recipient(s) who meets the criteria specified by the donor until all funds have been distributed.

Scholarship Distribution Process

Nevada Women's Fund relies on its Allocations Committee, made up of board members and dedicated volunteers, to review and score scholarship applications. This diverse committee brings a range of backgrounds and professional experience to the process. The Fund's President & CEO, along with the Director of Programs and Development, provide support to the committee, but they are not voting members.

Allocations Committee members receive thorough training on application evaluation and are guided by the board on priority areas. Applications are scored based on financial need, personal background, achievements and overall quality of submission.

The Workforce Ready scholarship cycle is quarterly, with the application process typically taking place in the 1st month of each quarter and awards made in the 3rd month of each quarter.
