ANNUAL SCHOLARSHIP PROGRAM

Establishing an Annual NWF Scholarship

Nevada Women's Fund offers a range of donor opportunities, and the establishment of an annual scholarship is a meaningful way to make a lasting impact. This option requires an annual commitment and allows the donor to specify the scholarship's use and purpose.

Key details for establishing an annual scholarship include:

- **Minimum Amount:** The minimum donation required to establish an annual educational scholarship is \$2,000.
- **Donation Deadline:** We request that donations be made prior to January 31 of the award year to ensure timely allocation.
- **Fund Management:** The Board of Directors of Nevada Women's Fund, or its designee(s), retains full authority over the management, investment, and administration of the restricted scholarship gift in accordance with the Fund's management policies.
- **Scholarship Allocation:** The scholarship fund will be allocated annually to a recipient who meets the criteria specified by the donor.

Scholarship Distribution Process

Nevada Women's Fund relies on its Allocations Committee, made up of board members and dedicated volunteers, to review and score scholarship applications. This diverse committee brings a range of backgrounds and professional experience to the process. The Fund's President & CEO, along with the Program Coordinator, provide support to the committee, but they are not voting members.

Committee members receive thorough training on application evaluation and are guided by the board on priority areas. Applications are assessed based on factors such as financial need, GPA, the quality of the personal statement, and whether the applicant is a returning student.

The Fund's scholarship cycle is annual, with the application process typically taking place in the 4th quarter of each year. Scholarship awards are intended to cover a full academic year, with announcements made in the spring and funds granted in the summer, prior to the start of the academic year.
